- 5 prominent research results (in PDF File)

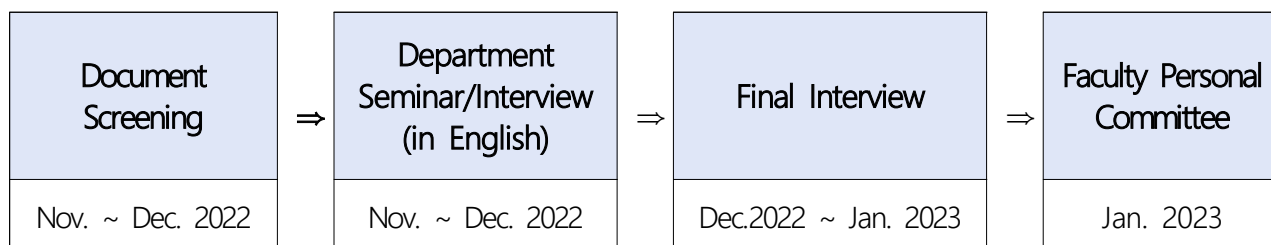

- Appointment shall be canceled in case of
  - 1) A false entry or modification is found in the application form
  - 2) impossible to obtain a Ph.D. as of appointment
- If a successful candidate or persons connected with that person involves solicitation, pressure, or the offering of favors in property, etc., that candidate will be subject to cancellation of acceptance and appointment.
- Appointment will be limited if the candidate is subject to disqualifications, set out in the State Public Officials Act, Article 33, or UNIST Faculty Personnel Regulations, Article 12.
- Other matters not specified in this announcement, follow UNIST Faculty Personnel Regulations & related regulations.
